

Supplemental HSE Requirements – Husky Midstream General Partnership

SUPPLEMENTARY HSE REQUIREMENTS

This appendix defines Husky Midstream General Partnership business unit specific HSE requirements to be complied with by the Supplier while performing services at the Husky Midstream General Partnership work sites. In some cases, the below requirements are in addition to or in replacement of, the requirements in HSE Schedule. If clarification is required, please contact your HMGP representative.

ORIENTATION AND TRAINING

The requirement below is in addition to HSE Schedule 3.3 Section 22 and 23

The following courses are required to access the HMGP sites:

- Corporate Safety Orientation
- Husky Pipeline and Terminals Site Orientation
- Site Specific Field Orientation (Delivered on Site with Operations)
 - Hardisty Terminal Site Specific Field Orientation
 - Cold Lake Terminal Site Specific Field Orientation
 - Lloydminster Terminal Site Specific Field Orientation
 - Midpoint Terminal Site Specific Field Orientation
 - Wainwright Site Specific Field Orientation
 - Visitor Site Specific Field Orientation
- Life Saving Rules Introduction
- H2S Alive
- WHMIS 2015 including GHS
- Standard First Aid/CPR – enough First Aiders onsite to meet the Provincial OHS requirement
- Husky Checkpoint Holder Training for all Supervisor and/or Permit Holders
- Non-Electrical workers entering electrical buildings must complete the Electrical Safety Standard for Non-Electrical Worker
- Electrical workers are required to complete:
 - Electrical Safety Training System <http://esps.ca/training/> for all external contract electrical workers, including instrumentation technicians
 - Electrical Safety Standard, Electrical Worker

PERSONAL PROTECTIVE EQUIPMENT (PPE) REQUIREMENTS

The requirement below is in addition to HSE Schedule 3.3 Section 40.

- Hoodies and hooded clothing are prohibited from all HMGP sites.
- Additional PPE may be required based on task and associated hazards. For example, respirators, fall protection equipment, non-sparking traction aids, task appropriate hand protection, etc.

DRIVING SAFETY

The requirement below is in addition to HSE Schedule 3.3 Section 41.

- All work vehicles and mobile equipment must be equipped with: – 20LB Fire Extinguisher / First Aid Kit / Emergency Kit
- Supervisor, safety, site visitor vehicles, not involved in the direct (hands on) completion of the task require a minimum 5lb fire extinguisher along with the First aid kit and Emergency kit.

MOBILE EQUIPMENT

The requirement below is in addition to HSE Schedule 3.3 Section 37.

All unmanned diesel equipment must be equipped with an Automatic Positive Air Shutoff.
