1.0 General Requirements

Cenovus Energy Inc. (Cenovus) as operator of the White Rose Field and Suncor Energy Inc. as operator of the Terra Nova Field (collectively the “Operators”) are seeking Expressions of Interest (EOIs) and Prequalification responses from interested companies for Integrated Logistics and Inventory Management (Reference No. 8.5.1.133).

Interested companies must be qualified to conduct the work as outlined in Section 2.0 below and are asked to demonstrate their capabilities and experience via a formal response to the Prequalification Questionnaire enclosed with this this EOI / Prequalification advertisement.

2.0 Request Summary

The Operators are seeking to prequalify companies who can develop and implement an integrated logistics and inventory management service model tailored to the Operators’ offshore operations in Newfoundland and Labrador.

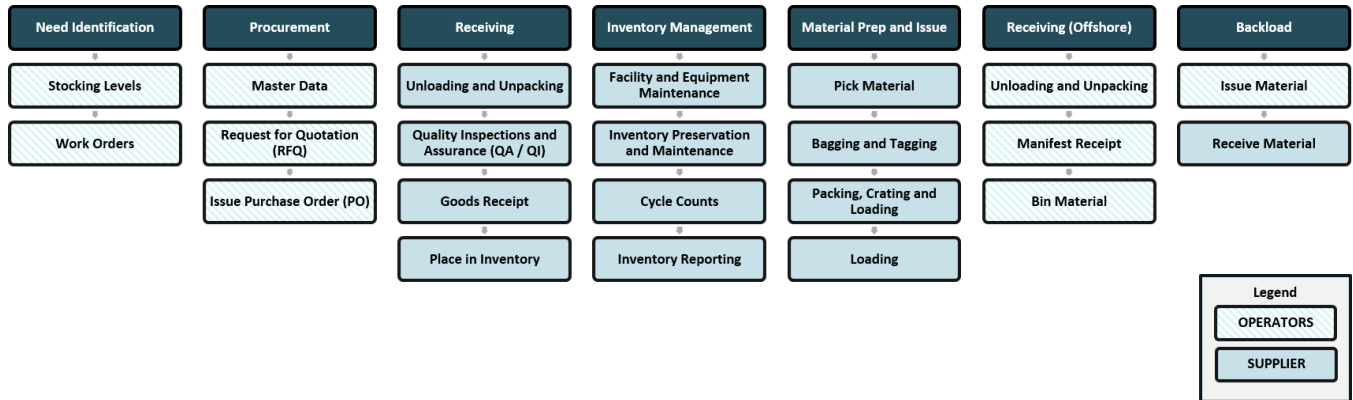
The primary objective is to secure a contract with a qualified and experienced contractor to develop an integrated and innovative service model (including facilities, tools, technology, resources and processes) which ensures the **correct materials** are **maintained in good working condition** and **delivered safely** to the Operators’ offshore facilities **on-time** and **in a cost-effective manner**. The successful candidate will be required to demonstrate how it will:

1. Optimize inventory management processes and warehouse/yard footprint;
2. Integrate the service model with the Operators’ respective systems and operations;
3. Scale the service and commercial model to meet Operators’ evolving requirements;
4. Leverage technology, innovation and industry best practices to maximize process efficiency, quality of service and cost competitiveness; and
5. Ensure a safe work environment and compliance with all applicable guidelines, standards and regulations.

The successful supplier will be responsible for executing a range of activities including:

1. Receiving materials at the designated facility;
2. Conducting quality inspections to validate documentation compliance and material specifications;
3. Bagging and tagging materials for easy identification and tracking;
4. Packing and crating items for safe transport to offshore locations;
5. Performing quality assurance/inspections activities;
6. Implementing robust inventory tracking systems and generating various regular reports as requested by the Operators; and
7. Conducting routine cycle counts to maintain accurate inventory records.

For clarity, below is a high-level summary of general supplier responsibilities in relation to Cenovus’s procurement and inventory management cycle:



As a reference for scale and capacity requirements relating to this scope of work, below is an overview of the Operators’ Atlantic Region operations and space requirements:

DESCRIPTION	CENOVUS	SUNCOR
Offshore Facilities	Cenovus operations include Searose FPSO (current) and West White Rose Platform (starting 2025), located approximately 350km offshore Newfoundland and Labrador. Long term scope may include additional rigs/facilities.	Suncor's operations include the Terra Nova FPSO located approximately three hundred fifty (350) kilometers east-southeast of St. John's, Newfoundland and Labrador. Long term scope may include specialized vessels including dive support vessels, construction support vessels and mobile offshore drilling rigs.
Warehousing	Cenovus is seeking approximately 80,000 – 100,000 sqft of warehouse space to accommodate inventory volumes.	Suncor is seeking approximately 40,000 square feet of warehouse space to accommodate inventory volumes.
