1.0 Introduction

The following represents Husky Energy's (Husky's) Canada-Newfoundland and Labrador Benefits Report for the quarter ending March 31, 2011, as required under the Conditions set out in Decision 2001.01 for the White Rose Development Project.

This report provides a summary of progress/activities related to Husky Energy's Atlantic Region and includes activities of its major sub-contractors as well.

2.0 Highlights for the Period

- Overall Canada / Newfoundland content for Husky's operations which includes the White Rose Project, North Amethyst Project, West Pilot Scheme and Exploration was 68.7% NL and 19.9% Other Canadian.
- Total employment for Atlantic Region operations was 1139 as of March 31, 2011, representing a content of 90% NL and 6% Other Canadian.
- All positions for Atlantic Region operations were located in Newfoundland and Labrador.

3.0 White Rose Employment Summary

As of March 31, 2011, a total of 918 people were employed on Husky's White Rose Operations of which 425 were located offshore. This includes people employed with Husky and its contractors. Of this total 848 or 92% were residents of Newfoundland and Labrador when hired, while another 53 or 6% were residents of other regions of Canada at the time of hire. All of these positions were located in Newfoundland and Labrador as at March 31, 2011. The number of females employed on White Rose operations was 162 or approximately 18% of the total workforce.

4.0 North Amethyst Tieback Project

North Amethyst development drilling related to the project continued in the first quarter of 2011. The G-25 4 well drilled in late 2010 was completed in January 2011. An additional two North Amethyst wells were drilled in this quarter with completions planned in Q2 2011. A total of 204 people were employed on the project as of the end of March 2011. Person hours for the period totaled approximately 93,763 bringing the total to date to almost 2.3 million.

The Exploration spend for the first quarter of 2011 was approximately \$1.62 million, with a content breakdown of 87% Newfoundland & Labrador. This is attributed to various subsurface studies and ongoing work in support of identifying future drilling targets.
