1.0 Introduction

The following represents Husky Energy's (Husky's) Canada-Newfoundland and Labrador Benefits Report for the quarter ending June 30, 2011, as required under the Conditions set out in Decision 2001.01 for the White Rose Development Project.

This report provides a summary of progress/activities related to Husky Energy's Atlantic Region and includes activities of its major sub-contractors as well.

2.0 Highlights for the Period

- To date, over \$6 billion has been expended by Husky on projects in the Atlantic Canada region, almost half of that directly spent in NL.
- Overall Canada / Newfoundland content for Husky's operations which includes the White Rose Project, North Amethyst Project, West Pilot Scheme and Exploration was 61.33% Newfoundland & Labrador, 24.73% Other Canadian, and 13.94% Foreign.
- Total employment for Atlantic Region operations was 1115 as of June 30, 2011, representing a content of 91% NL and 5.5% Other Canadian.
- All positions for Atlantic Region operations were located in Newfoundland and Labrador.

3.0 White Rose Employment Summary

As of June 30, 2011, a total of 891 people were employed on Husky's White Rose Operations of which 434 were located offshore. This includes people employed with Husky and its contractors. Of this total 829 or 93% were residents of Newfoundland and Labrador when hired, while another 48 or 5.4% were residents of other regions of Canada at the time of hire. All of these positions were located in Newfoundland and Labrador as at June 30, 2011. The number of females employed on White Rose operations was 161 or approximately 18% of the total workforce.

4.0 North Amethyst Tieback Project

North Amethyst development drilling related to the project continued in the second quarter of 2011. The G-25-6 well was completed and the G-25-5 well was drilled with completion to be finished in Q3. A total of 212 people were employed on the project as of the end of June 2011. Person hours for the period totaled approximately 98,544 bringing the total to date to over 2.4 million.
